2021 AFTCT Legislative Priorities

Coalition Issues

- Recovery for All Coalition - AFT CT will work in coalition of Labor, Faith and Community Organizations around revenue options to We need a recovery for all that:
 - Reduces the vast income inequality that impedes economic growth;
 - Fairly updates our tax code to raise \$3 billion from progressive revenue sources to fortify state finances and build our future;
 - Makes historic investments in education, workforce development, healthcare, housing and other vital public services that undo the inequities and disparities in our state budget; and
 - Builds a strong economy where each one of us can thrive.
- A Public Option – AFTCT will work in coalition with Comptroller Lembo and Labor and Community Organization to establish a public option to allow the State of Connecticut to leverage its market power to offer small businesses, non-profits and Taft-Hartley plans the opportunity to purchase high quality, affordable healthcare.
- Post-Janus Legislation – AFTCT will work in coalition to ensure the rights of public employees to join or support a union

Citizen Lobbying

We all lobby all the time. Whether it is lobbying to convince a friend to see a certain movie, a child to clean their room, the boss for a raise, a co-worker to help on a project- we all lobby to get things we want. We list the arguments for our position, we point out the problems with the other side's arguments, we enlist the help of those who are more powerful in the situation and we use our own position of power in the situation to get our way. All of this is lobbying. All are techniques used to lobby the Connecticut General Assembly.

A Few Facts about the Connecticut General Assembly

Keep in mind – the only truly universal rule in the legislative process is that there is no universal rule in the legislative process.

In 2021, the General Assembly opens on January 6, 2021 and will adjourn on June 9, 2021. Regular sessions of the General Assembly are held from January to June in odd-numbered years, and from February to May in even-numbered years. The state constitution restricts the shorter, even-year sessions to consideration of budgetary, revenue, and financial issues, bills and resolutions raised by committees of the General Assembly, and emergency matters.

The Governor may call special sessions in case of emergency. Also, a majority of the members of either chamber of the General Assembly may petition for a special session.

A post-adjournment, or *trailer*, session is required to reconsider any bills vetoed by the Governor and not acted upon again by the legislature before the close of a previous regular or special session.

Membership

There are 151 House of Representative Members and 36 Senators in the General Assembly. The Governor, Ned Lamont and the Lt. Governor, Susan Bysiewicz, are both Democrats. The Lt. Governor serves as the President of the Senate meaning she presides over the Senate, but she only votes if there is a tie. The highest-ranking member of the Senate is the President Pro Tempore, Martin Looney, and a Democrat. He is elected by the membership of the Senate. The House of Representatives is presided over by the Speaker of the House, who is Matt Ritter, a Democrat. He is a member of the House and elected Speaker by the House members.

The Senate

Connecticut's Senate has 36 members, each elected from a separate senatorial district of substantially equal population. The state constitution permits the size of the Senate to vary from 30 to 50 members. The Senate:

- ❖ determines its own rules and procedures.
- ❖ is presided over by the Lieutenant Governor, who is President of the Senate. The Lieutenant Governor may cast the deciding vote in case of a tie.
- ❖ elects a President *Pro Tempore* (temporary president) who presides in the absence of the President and serves as a party spokesperson. The President *Pro Tempore* appoints the Senate chair of joint committees and Senate committee members.
- ❖ has a Majority Leader and a Minority leader who also serve as party spokespersons. Elected by Senate members of their own party, these leaders direct party affairs, assemble members for important votes, and serve as *ex officio* members of all committees.
- ❖ tries all impeachments of executive and judicial branch officials.

The House of Representatives

The House of Representatives has 151 members, each elected from a separate assembly district of substantially equal population. The state constitution permits the size of the House to vary from 125 to 225 members. The House:

- ❖ determines its own rules and procedures.
- ❖ is presided over by a Speaker of the House, elected by the members. The speaker is a party spokesperson and appoints the House chairs of joint committees and House committee members. The Speaker also may refer bills to appropriate committees.
- ❖ has a Majority Leader and a Minority leader who also serve as party spokespersons. Elected by House members of their own party, they direct party affairs, assemble members for important votes, and serve as *ex officio* members of all committees.
- ❖ has the power to impeach executive and judicial branch officials.

How the General Assembly Does Its Work

The General Assembly meets in the State Capitol in Hartford. General Assembly committees meet and hold most public hearings in the adjoining Legislative Office Building, which houses members' offices.

Connecticut's legislature is one of the few that traditionally operate with a system of joint House and Senate committees. Committees, which may operate on a year-round basis, meet to review proposed legislation, and make recommendations to the full House and Senate. The joint committee system minimizes duplication of effort, saving both time and expense. It also spares the public from having to appear before separate House and Senate public hearings on the same legislation.

In most cases, committee members represent each political party in relative proportion to its number in each chamber. Two committee chairs are appointed from the majority party, one by the President *Pro Tempore* of the Senate and one by the Speaker of the House.

There are currently more than twenty joint standing committees that focus on specific legislative issues for that committee. Most senators and representatives serve on several committees.

Some committees use subcommittees to handle the volume and complexity of the work that comes before them. Professional and technical support is available to legislators through the Joint Committee on Legislative Management, which supervises various non-partisan offices and commissions staffed by experts.

Lobbying Through the Mail or Email

First, you should remember that we have a small state and a large General Assembly. These legislators are your neighbors. Once you have met your representatives, you will likely run into them in the supermarket and at the post office. They also want and expect to receive letters and phone calls on issues and use these as an important source of information when they decide how to vote.

Unlike Congress, members of the General Assembly do not have a lot of staff. They also do not receive a lot of phone calls or mail on most issues. Legislators acknowledge that they are impressed and give special attention to an issue if they receive even 10 letters or phone calls about a particular subject.

So, it is important that you write that letter -- it does make a difference.

Ask someone why she/he has never written to a legislator and invariably she/he will say, "I don't know what to say or how to say it." But there is nothing mysterious or even difficult about writing to your representative in Hartford. Here are a few pointers to make writing that letter a little easier.

- Keep it short. One page is probably sufficient.
- Write in your own words and include your own thoughts.
- Discuss only one issue and deal with the major points one at a time. Make your points factual and be concise. Let the legislator know you are familiar with the issue and have given it thought. Save other issues for later letters.
- Give reasons for your position briefly. Cite your own experience or observations if possible or point out that a local law or practice like the one you are lobbying is in effect and working.
- If the bill has a local impact, indicate it so your legislator realizes the bill will have a direct effect on his district.

- Be reasonable. It is perfectly all right to disagree with the legislator's views, but don't get angry. A thoughtful, well-written letter will do more to win your legislator to your viewpoint than a threatening, negative one.
- Be specific as to what you want your legislator to do. Refer to the bill by name and number if you know it, but never just by number.
- Don't worry about form. **Any letter is better than no letter.** Pen, typewriter, e-mail or pencil, even a postcard is O.K. as long as your message gets through and is in your own words. Be sure it is legible.
- You can e-mail your legislators by going to the CT General Assembly website (www.cga.ct.gov) and follow the directions or look at the back of this book.
- Send a copy of your letter or e-mail to your local newspaper to build local support for an issue.
- After you've written once and have received a reply, keep up the contact. Periodically write additional letters, let your legislator know you've followed the votes on your issues, and thank her/him for the support or express your displeasure for the lack of support. Let your legislator know you are watching and interested.

Here's an example:

Dear Representative _____ (or)

Dear Senator _____ (or)

I am a AFT Connecticut member; I live in your town and would like you to support legislation that establishes standards for privatization of public services. In addition to protecting jobs. I care deeply about the quality and availability of public services, including public education (this is where you should insert a few sentences about why you are personally interested. It does not have to be long and for example, could be that you have children or grandchildren).

I would greatly appreciate it if you would keep me informed about any legislation on this issue this session. I would be glad to provide you with additional information about privatization of public services, including education.

Thank you for your consideration of this important issue.

(Sign each copy of the letter and include your address and contact information.)

Making A Phone Call

Some people may think it is easier to communicate by phone than to try to find the time to write a letter. Any type of contact is important!

Most of the suggestions for writing letters apply to phone calls as well. Make the call short, polite, and to the point.

You can call the legislator at home. They expect it. Leave a message if you don't reach him/her. But try back if you don't get to talk to your legislator. **Don't call too early in the morning or too late at night.**

If you get a machine leave a message as to what you want the legislator to do, e.g. "please vote for House Bill 0000, legislation that sets standards for privatization." Make sure you never refer to a bill by number only, always include the title or say what it does. If a child answers the phone, ask if you can call back and leave a message on the machine.

Don't worry if you don't know the answer to a legislator's question. Promise to get back to him/her with an answer and DO.

Again, follow-up on the call. Be sure to call back and thank the legislator for their support or very politely express regret at their vote.

Lobbying in the District

Visiting state legislators is an important part of the overall lobbying effort. A citizen visiting her/his State Representative or Senator is visibly identifying herself/himself as a constituent and voter. Because she/he is focusing on you as an individual and as a voter, your visit will have a greater impact than a letter or phone call. These few guidelines can help you to get your messages across directly and effectively.

- Make an appointment by calling the legislator at home or at the Capitol.
- Indicate the issues you want to discuss at the interview.
- Whenever possible, two or more members should go together on lobbying visits. Arrive on time.
- Keep the atmosphere at the meeting friendly and open; you are there to exchange ideas. Under no circumstances should anyone become angry. As in any situation, anger only works negatively and will not further your objective of gaining the legislator's support.
- Limit the time of the meeting. Set a definite beginning and ending time sufficient to handle the issues you want to discuss, but not so long that the discussion drags. Morning coffees and afternoon snacks at your house are a great way to hold these meetings.
- If you don't know the answer to a question the legislator asks, just say so and explain that you will get the information she/he wants. Then be sure to follow through.
- Leave some literature with the legislator either on the issue, or general information about the AFT Connecticut. This will help her/him to remember your visit.
- Follow up on your visit with a thank you note and perhaps more information on the issues you discussed. Remember, your main objective is to establish a

continuing dialogue with your legislators and establish the AFT Connecticut as a reliable source of information.

Testifying At Public Hearings

At hearings, you can learn what others with different views on the issue are saying. Remember, if no one comes to testify on the issue, legislators can use that as an excuse to kill the legislation (no public interest in it) or to pass/kill bad legislation (there was no opposition): "No one testified against/for the bill."

How Do You Find Out About Hearings?

Every day during the legislative session, the legislature publishes a Legislative Bulletin. This Bulletin contains the notices of hearings. The only place to get this publication is at the Legislative Office Building (LOB), Room 1400, or you can get it on-line: the website is: www.cga.ct.gov. Few people have the time to actually go to the Capitol to get a copy of the Bulletin and not everyone has a computer.

How Much Notice Will I Get?

Unfortunately, the legislature's rules do not require a lot of notice. The rules mandate five days (days, not business days - sorry) notice for a hearing and three days' notice of which bills will be heard at that hearing. The committees sometimes give more notice, but it is not the requirement.

For example, the Labor Committee will put a notice in the Bulletin that it is having a hearing on binding arbitration five days before the hearing, but not list the actual bills until three days before the hearing. The notice will have the date, time, room and subject of the hearing. The notice often contains the procedures for that hearing as well.

What Should I Expect at the Hearing?

People may be a bit anxious and upset at their first legislative hearing because they don't know what to expect. Expect that there will be a wait – and it could be really long!

The first hour of a public hearing is usually reserved for lawmakers and state officials. But arrive well before the scheduled start of the hearing to sign up for the public portion. It works a lot like the deli counter of a grocery store. Those with the lowest number testify first. But, some committees will also listen to testimony by bill number. Designate the bills on which you will testify and whether you are for or against the proposal.

It is a good idea to listen to the testimony of the people before you, especially that of the state agency representatives. They can give the latest information on the legislation and it is important to know their position. It is also important to be able to refute the other side's argument. Also, you do not want to just repeat what everyone else has said.

Expect that legislators will come and go often. Legislators are on many committees and have other meetings or hearings going on at the same time. Legislators have been known to eat during hearings and to talk to each other while someone is testifying. While this may seem disrespectful to you, it is the nature of the process, so you need to do some things to be sure your testimony is heard.



- What happens if this bill does pass/doesn't pass?


